OPERATIONS

Significant Alarms

August 18th, 2022: Residential Structure Fire in Clearview

SRFR units B71, L72, and A77 were dispatched with South County Fire for a Residential Fire on the 12400 Blk of 51st Ave SE. Multiple callers reported an explosion with a resulting fire. Units arrived to find a medium sized two-story house with extensive fire conditions. A second alarm was requested. Firefighters extinguished the fire. There were two individuals inside the house at the time of the fire. One was transported to Providence with non-life-threatening burn injuries. The incident is under investigation by the County Fire Marshal.

August 24, 2022: 20:20 Motor Vehicle Collision (Officer Involved)

East Battalion units were dispatched to assist multiple law enforcement agencies for a possible officer involved motor vehicle collision (MVC). Units arrived to find a two-vehicle head on accident with two patients with moderate injuries. M31 treated and transported a King County Deputy with moderate injuries. A51 transported an adult female with minor injuries who was combative and intoxicated with threats to self and suicidal tendencies.

Accreditation

SRFR continues to make good progress towards accreditation from the Center for Public Safety Excellence (CPSE). During the week of September 18, a CPSE Peer Evaluation Team will be visiting SRFR to evaluate the organization and determine SRFR's qualification status for accreditation. Pending a successful evaluation, SRFR is slated to go before the Accreditation Board for final approval February 2023 in Orlando, Florida.
